

Alaska's Governor Mike Dunleavy; Attorney General Treg Taylor; and Legislature:

This is a complaint that Superior Court Judge Jennifer Wells violated Alaska's constitution; AS 11.56.510 (Interference With Official Proceedings, a B Felony); and AS 11.56.590 (Jury Tampering, a C Felony).

On June 29, 2022, a Kenai grand jury, by majority vote, voted to investigate evidence of public corruption within Alaska's judicial system. Prior to witnesses being sworn or evidence presented, Judge Wells ordered the grand jury to stop investigating and permanently dismissed the grand jurors from duty. Jurors never got to see or hear anything; not even direct evidence that the only investigator of Alaska's judges for the last 30 years and counting (Marla Greenstein) is falsifying official investigations to keep corrupt judges on the bench – and then falsifying certified documents to cover up. 
Article 1, Section 8 of Alaska's constitution states: *"The power of grand juries to investigate and make recommendations concerning the public welfare or safety shall never be suspended."*

Comments by the 55 delegates who wrote Alaska's Constitution confirm that grand juries (made up of normal citizens) are the public's independent oversight of government officials/agencies: *"The grand jury is preserved, for all purposes, particularly for investigation of public officials. The power of grand juries to inquire into the willful misconduct in office of public officers, and to find indictments in connection therewith, shall never be suspended. The grand jury can be appealed to directly, which is an invaluable right to the citizen."*

In March 2022, Judge Wells and Deputy Attorney General John Skidmore stopped a different grand jury from investigating the same corruption. Although the Governor was informed and Criminal Director Angie Kemp was assigned to investigate (she admitted Skidmore is her boss), nothing happened. At least four other grand juries are known to have been stopped by the same officials/entities the grand jury was investigating - with nothing done when complaints were filed. To pass a resolution protesting the forgoing, the Kenai Peninsula Borough Assembly found evidence that grand jury investigations have been stopped for the last 30 years.

There must be a recorded face-to-face meeting with the Governor; Attorney General; concerned citizens (at least David Haeg, James Price, Scott Egger, and Don Fritz); and legislators (at least Ben Carpenter and Peter Micciche) to discuss the situation. Afterward the grand jury that was unconstitutionally suspended on June 29, 2022 must be called back and complete a thorough and public (TV, radio, and online coverage) investigation complete with recommendations and/or criminal indictments – with the grand jury given funds to pay for independent legal counsel and investigators to assist.

If the grand jury investigation described above does not take place promptly, concerned Alaskans will conduct a sit-in at the Kenai Courthouse until it does. All wishing to join a sit-in should email [haeg@alaska.net](mailto:haeg@alaska.net) or text David Haeg at (907) 398-6403.
