Dear friends and family,

Alaska Court of Appeals scheduled oral arguments (30 minutes per side) for May 20, 2014 at 1:30 PM on the 5th floor of the Boney Courthouse at 303 K Street, Anchorage, AK 99501 (907-264-0612). I beg everyone possible attend - as it will expose widespread corruption in Alaska's judicial system that the courts, the Alaska Commission on Judicial Conduct, and Alaska Bar Association have been trying to keep covered up.

After 9 years the Court of Appeals allowed in the physical evidence of corruption, conspiracy and cover up - a shocking change from their past denials - maybe because 2 of the 3 judges were replaced. The evidence proves everyone (my own private attorneys included) destroyed all evidence I was being prosecuted for the exact actions the State permitted me for and told me I must take for the good of the public during the wolf control program; manufactured evidence against me that everyone knew was false when they presented it to my jury; and lied to deprive me of very nearly every right that is specifically guaranteed by the U.S. constitution.

The Court also allowed me to use the tape-recorded sworn testimony of my own attorneys that the State threatened them so they would help the State do the above. The briefs detailing the certified evidence I will present can be found in opening and reply briefs at: www.alaskastateofcorruption.com

As long-time Alaskan attorney Dale Dolifka testified after reviewing the evidence: "Shades of Selma in the 60's, where judges, police, and attorneys were all in cahoots together. It's absolute, unadulterated, self-bred corruption...it will get worse until the sleeping giant [you the public] wakes up." Dolifka also testified that "if the court does right by you the judges will go down, the Troopers will go down, and the attorneys will go down." I need everyone present to make sure the Court of Appeals "does right."

It has taken 10 years of heartache, everything my family had, and help from across the world to be able to finally force these oral arguments - where I can finally present the evidence and the public (if they attend) can see for itself if the State, the judges, the Troopers, and/or the attorneys can refute it.

I will finish by stating I am flying to Washington D.C. to present the evidence to the Department of Justice, U.S. congress, and to PBS's Frontline program and that unless the Court of Appeals overturns my conviction and orders a comprehensive, independent investigation of my prosecution by Henry Schulke (who investigated Senator Ted Stevens prosecution) - I will, on July 4, 2014, go get the airplane and other property I used to feed and shelter my beautiful wife and daughters (from where the State impounded it at their Lake Hood facility over 10 years ago) - or die trying. If I cannot wake the sleeping giant with my life maybe I can wake it with my death.

Some say I am over-reacting. But Dolifka also stated I am lucky they only ended my master guide career and put me in jail for a couple months; that he and others know of numerous people who have been "crushed" totally - sentenced to decades in prison for incredibly serious crimes that were knowingly fabricated by the judges, prosecutors, and defense attorneys; that my case is the "leading edge" of Alaska's judicial corruption; and that so far the media has been afraid to expose any of this.

So I fight not just for myself - I fight for all those unjustly imprisoned because they had not the strength, intelligence, and/or resources to fight for themselves.

More importantly, I fight for the "millions yet unborn" who will be at risk if this evil is allowed to grow unchecked.

I am treating this exactly as if I were living in 1940 Germany, personally experienced government corruption, and heard of plans to build facilities at Auschwitz, Sobibor, Belzec, Chelmno, Bergen-Belsen, Dachau, and Buchenwald. I am going to do everything in my power to wake "the sleeping giant" to widespread government corruption before anything like gas chambers and concentration camps can be built - and my daughters and yours face this without us there to protect them. Just how many millions would take the exact course I have decided upon had they known what unchecked government corruption in Germany would lead to?

"The liberties of our Country, the freedom of our constitution, are worth defending at all hazards: & it is our duty to defend them against all attacks. We have receiv'd them as a fair Inheritance from our worthy Ancestors: They purchas'd them for us with toil & danger & expence of treasure & blood; & transmitted them to us with care & diligence. It will bring an everlasting mark of infamy on the present generation, enlightened as it is, if we should suffer them to be wrested from us by violence without a struggle; or be cheated out of them by the artifices of false & designing men. Let us remember that 'if we suffer tamely a lawless attack upon our liberty, we encourage it, & involve others in our doom.' It is a very serious consideration, which should deeply impress our minds, that millions yet unborn may be the miserable sharers of the event." Samuel Adams, U.S. Founding Father

I believe this scandal will dwarf that of Illinois, where 92 officials were indicted in a single investigation (17 judges, 48 attorneys, 8 policemen, 10 deputy sheriffs, 8 court officials, and 1 legislator - with most pleading guilty). Just one part of my case proves the only investigator of

Alaska's judges for the past 27 years (Marla Greenstein) is falsifying official investigations to keep crooked judges on the bench. (The evidence of this was certified as true by Superior Court Judge Stephanie Joannides.) Greenstein - who is <u>still</u> Alaska's only investigator of judges - receives more than 10 complaints against judges a month - 120 complaints a year times 27 years equals well over 3000 judges alone that may have been, or are, corrupt here in Alaska.

I am attaching a 8.5x11 flyer that I am getting bids to have printed/distributed. So far AT Publishing gave a price of \$4737.30 for printing/bundling of 31,582 flyers (don't know why they picked this number) on 100# cardstock (15 cents a piece) and \$5274.19 (\$0.167 per piece) for Every Door Direct Mailing. We can pick the zip codes that get them and I thought it best to send them to postal customers closest to the Court of Appeals. On the Kenai Peninsula I thought we could print them on regular copy paper (\$0.04 a copy) and hand them out door to door. Jackie and I can pay about half of the EDDM printing/mailing without going further into debt and maybe some of you can help with the rest. \$0.32 per flyer printed/delivered doesn't sound too bad, maybe we could find someone cheaper, or maybe we should just hand them out. If anyone has any ideas on how best to get the word out let me know. We are on Facebook and will try to get the word out there also - maybe you all can do the same.

As always, a humble thank-you to everyone who has given money, time and/or effort to help us through this - without which we would have never made it. And as always, please forward this email on to any and all that you can - for it identifies and exposes an incredible danger to us all. Most of all please attend the public hearing on **May 20, 2014 at 1:30 PM on the 5th floor of the Boney Courthouse at 303 K Street, Anchorage.** There is absolutely no doubt that at this point if the courtroom/courthouse are full we all will have won before the hearing ever starts.

At 8 am on May 20th my family and I will park at the intersection of Gambell/4th Avenue and walk to the courthouse down 4th Avenue, asking people to join us at the court in opposing Alaska's judicial system being held hostage by corruption.
