Haeg moved for full court reconsideration of Chief Judge Coats’s 12/3/07 order denying Haeg’s request to supplement the appellate record in Case No A-9455 with proceedings from the Alaska Bar Association and the Alaska Commission of Judicial Conduct.

Haeg also asks the full court to reconsider Chief Judge Coats’s 12/3/07 ruling that Haeg’s request to expedite consideration of his petition for review in Case No. 10015 was moot. The Court will treat this as a motion to expedite consideration of Haeg’s appeal in Case No. 10015.

In addition, Haeg requests that the Court consider as part of his briefing in Case No. 10015 his 10/29/07 motion for a ruling on his petition for review and his motion for its expedited review. Finally, he requests to supplement the appellate record in Case No. 10015 with proceedings from the Alaska Bar Association and the Alaska Commission of Judicial Conduct.

The State has not opposed Haeg’s requests.

IT IS HEREBY ORDERED:

1. Haeg's motion for reconsideration is **GRANTED**.

3. Haeg's request to expedite consideration of his appeal in Case No. A-10015 is **GRANTED**.

4. Haeg's request that the Court consider as part of his briefing in Case No. 10015 his 10/29/07 motion for a ruling on his petition for review and his motion for its expedited review is **GRANTED**. His request to supplement the appellate record in Case No. 10015 with proceedings from the Alaska Bar Association and the Alaska Commission of Judicial Conduct is **DENIED**.
