On and just after March 29, 2004, or nearly 4 years ago, David Haeg's property, used as the primary means to provide his livelihood, for his family of 4, was seized, deprived, and then forfeited in violation of due process.

Since the seizure David Haeg has been trying as diligently as possible to obtain the return of his property.

On January 29, 2008 this Court of Appeals graciously granted David Haeg's motion to consider this appeal on an expedited basis.

David Haeg now respectfully asks this Court of Appeals to schedule the already granted oral arguments as soon as possible as briefing in this case is complete.

It is David Haeg's sincere hope that he may receive an order from this Court of Appeals returning his property before he and his family must sell or lose any more irreplaceable possessions. Spring is almost here *again* and David Haeg must have the tools with which to provide for his family.

David Haeg hopes this Court of Appeals does not consider this motion redundant and irritating – the Haeg family's situation is desperate.
