**STATE'S MOTION TO STRIKE APPELLANT'S MOTION TO  
SUPPLEMENT THE RECORD OF DAVID'S CRIMINAL APPEAL WITH  
OFFICIAL PROCEEDINGS BEFORE THE ALASKA BAR ASSOCIATION  
AND THE ALASKA COMMISSION OF JUDICIAL CONDUCT**

Comes now the Appellee, the State of Alaska, by and through Assistant Attorney General Andrew Peterson, and files this Motion to Strike Appellant's Motion titled "Motion for Ruling on Petition for Review & The Motion for Its Expedited Review and to Supplement the Record of David's Criminal Appeal with Official Proceedings before the Alaska Bar Association & the Alaska Commission of Judicial Conduct."

The State will address Haeg's motion in two parts. First, Haeg's motion for Ruling on Petition for Review and the motion for its Expedited Review are moot given this Court's Order dated November 6, 2007. This Court ruled on November 6, 2007 that it was converting Haeg's Petition for Review into an appeal. This Court further indicated that it was considering

the briefing on this appeal final. Consequently, the State will not respond further to these two parts of Haeg's motion.


Second, Haeg asks this Court to supplement the record on his criminal appeal with the official proceedings before the Alaska Bar Association and the Alaska Commission of Judicial Conduct. The State objects to these proceedings supplementing Haeg's record on appeal due to the fact that they are not part of the district court file pertaining to Haeg's conviction. *See* Rule 217(c). Additionally, this Court's Orders from September 6, 2007 and November 6, 2007 clearly indicated that Haeg's record on appeal is limited to the district court proceedings in this case. Finally, the State objects to these proceedings supplementing Haeg's record due to the fact that the State was not a party to these proceedings.

The State respectfully requests that for the above stated reasons, the Appellate Court strike Haeg's motion to supplement the record of David's Criminal Appeal with Official Proceedings before the Alaska Bar Association and The Alaska Commission of Judicial Conduct.
