It you agree to a prompt second meeting (where you will discuss in detail the specific circumstances, events, evidence, and persons indicating corruption and/or requiring the appointment of an independent commision that investigates in public - including but not limited to attachments 1 thru 15

in the emails below, which you will have examined prior to meeting) we will agree to meet with you to discuss *"the investigative grand jury process"* and related issues.

However, if you do not intend on going through with a meeting to discuss corruption specifics justifying appointment of an independent commission that investigates in public - or use the *"grand jury process"* meeting as a ruse to deny a later meeting, we respectfully decline to attend the first meeting - as we believe the second will protect the public's welfare and safety to a far greater degree. In your email below you state that before a second meeting you would need to *"be clear about the discussion topic"*. Attachments 1 thru 15, which are already in your possession, make the topic crystal clear.

Five of us (including two Borough Mayors) have been juggling schedules for many weeks in a goodfaith effort to meet with you. # Ms. Dizon (*Ms. Mason, we respectfully ask you to immediately give the Governor this email thread and ask he read it, prior to our February 12 meeting, so he may head off the rapidly expanding constitutional crisis*),

I wrote an email at 8 AM on February 10 (below) concerning the Department of Law's repeated demand to change our meeting - from exposing judicial corruption with an independent commission to something that will not expose corruption. Ever though the corruption implicates the highest levels of the Department of Law, up to and including Deputy Attorney General John Skidmore (see below email thread that caused Deputy AG Skidmore to be removed from our meeting).

In a 9:08 AM text on February 10, Don Fritz suggested waiting to send the email - in hopes that you, Deputy Attorney General Cori Mills, and Chief Assistant Attorney General Anne Helzer would realize that our letter to the Governor - that he must appoint an independent commission to investigate judicial corruption in public - absolutely requires a discussion of the particular circumstances, events, and implicated persons that would justify such a commission. Yet your 3:37 PM email instead makes a bizarre claim: *"Representatives from the Attorney General's office have agreed to meet with Mr. David Haeg for the narrow purpose of considering Mr. Haeg's ideas on an improved process for citizen-initiated requests for an investigative grand jury in Alaska."* This is bizarre because the Governor himself asked you to meet with multiple Alaskans (not just David Haeg) to: "*discuss fixing Alaska's judicial corruption with an appointed commission."* (see below Tue, 17 Dec 2024 04:42 email from Governor) This was in direct response to our letter to the Governor titled *"RE: Fixing Alaska's Judicial Corruption with an Independent Commission that Investigates in Public"*. How did *"Fixing Alaska's Judicial Corruption with an Independent Commission that Investigates in Public"* become *"an improved process for citizen-initiated requests"*?

We believe the Governor may be interested in finding out that you are defying <u>his</u> request that you meet with us to discuss <u>our</u> concerns in our letter to him. (see attached Governor Meeting Request) The Governor may be interested in learning the Department of Law even printed their own agenda for the meeting and are demanding we agree to it, <u>after</u> we had already given the Department of Law our agenda (attached) - for the meeting <u>we</u> requested and the Governor himself granted.

Most importantly, we believe the Alaskan public will be absolutely outraged when they read this email thread (and attachments) and realize the size of the scandal the Alaska Department of Law is now

trying to cover up - and the incomprehensible harm it represents to the public welfare and safety.

After this meeting we will humbly ask that <u>ALL</u> Alaskans join us in demanding that the Governor (**907-465-3500**) himself (as originally requested) meet with our team so they can present the *"particular persons, circumstances, situations, and evidence"* requiring he appoint an independent commission to investigate judicial corruption in public. For the meeting the Department of Law is now providing is not the meeting the Governor granted us. In fact, the Department of Law's act of changing this meeting is, by itself, proof of why an independent commission must be appointed.

In response to your last email:

1. We will meet with Department of Law attorneys Cori Mills and Anne Helzer on February 12, 2025 from 1:30 - 3:00 PM in Anchorage at Department of Law offices.

2. Five (5) members of our team will attend and take part in the discussion. Their names are Edna DeVries (Mat-Su Borough Mayor - likely attending in person); Peter Micciche (Kenai Peninsula Borough Mayor - likely attending via Zoom); Don Fritz (Funny River Board - likely attending in person); Ric Davidge (Alaska Roundtable - likely attending in person); and David Haeg (likely attending in person).

3. The "Department of Law will not consider discussion of persons, circumstances, situations or evidence presented by Mr. Haeg in support of any past or present claim of systemic corruption or judicial corruption at this meeting." (This is from the Department whose sole purpose is to prosecute crime and protect the public and which has been requested by the Governor to meet with folks who wish to present judicial corruption evidence that requires the appointment of an independent commission to investigate in public - see attachments.)

4. The meeting will be recorded and a copy given to the public, Governor, and Legislature.

Ms. Dizon,

1. Regarding your concern of not having time to review the documents we provided: pertinent parts are highlighted - which should only take about 30 minutes to review. Again, we humbly ask you to do so. Several of us are driving nearly 8 hours just to attend this meeting, so it would be fundamentally unfair for you not to be prepared.

2. Regarding your statement:

"The purpose of the February 12th meeting, as we understand it, is to hear your proposal how best to handle citizen-initiated requests for an investigative grand jury in Alaska. As for any particular persons, circumstances or situations, we do not believe it will be productive to spend time going over individual scenarios. Rather, the most productive use of the meeting will be for you to discuss your concerns about the current process, and to

provide us with any suggestions you have to best serve the public. Please respond to this email letting us know that you will agree to above scope and expectations for the meeting on February 12 at 1:30 PM."

For the second time (see below email thread), this meeting is to address the issues in our November 24, 2024 letter to the Governor (attached). This letter is titled, *"RE: Fixing Alaska's Judicial Corruption with an Independent Commission that Investigates in Public"*. In the Governor's email setting up our meeting, the Governor confirmed the subject of the meeting: *"Thank you again for the request to meet with the Governor and Attorney General to discuss fixing Alaska's judicial corruption with an appointed commission."* 

For us to successfully make the case that the Governor must appoint a commission that investigates in public, we must discuss particular persons, circumstances, and situations. To bar us from doing so will almost certainly doom our mission to failure.

We clearly understand why you wish to avoid discussing particular individuals, circumstances, and situations: many involve corruption, crime, and cover-up by individuals that you work with in the Department of Law. (see attached Meeting Agenda, Reasons for Independent Commission, and Timeline for names, circumstances, and situations) In fact, you are described below as *"Ninia Dizon with Mr. Skidmore's office"* and this meeting was first scheduled with John Skidmore, Alaska's Deputy Attorney General. It was only our discussion of evidence that he illegally stopped a grand jury investigation into judicial corruption, and then lied to legislators to cover up what he had done (see email thread below), that caused him to be removed from our meeting. You have been placed in a very unfair situation in which you are being asked to facilitate a meeting which may result in the firing and imprisonment of your boss.

Don Fritz's email (attached below) also addresses your apparent confusion about this meeting and reinforces the need to present evidence and discuss particular persons, circumstances, and situations.

To reiterate our expectations for the meeting that were communicated last week, Cori Mills and Anne Helzer have agreed to meet with David Haeg from 1:30-3:00PM. In that meeting, we will consider Mr. Haeg's ideas on how best to implement citizen-initiated requests for an investigative grand jury in Alaska on a matter of public welfare and safety. While we cannot guarantee that all ideas brought to our attention at this meeting will be implemented, we are also interested in learning about the potential to form an independent commission that could oversee or play some other role in citizen-initiated grand jury investigations. The discussion could also include Mr. Haeg's thoughts on what the potential duties, responsibilities, and authority of an independent commission might look like. To be very clear, we will not discuss any persons, circumstances, situations, or topics, nor will we review evidence presented by Mr. Haeg in support of any past or present claims of systemic corruption or "judicial corruption" at this meeting.

Thank you for the offered meeting dates regarding Governor Dunleavy appointing an independent commission to publicly investigate judicial corruption in Alaska. We are available either **January 28 or 29** to meet with Deputy Attorney General Cori Mills and Chief Assistant Attorney General Anne Helzer.

Because of the great danger to the public welfare and safety, and the possibility of miscommunication during virtual meetings, Mr. Fritz and I plan on flying to Juneau so we may meet with Deputy Mills in person. Mat-Su Borough Mayor Edna DeVries and Ric Davidge plan on meeting with Chief AAG Helzer in person in Anchorage.

We are agreeing to this meeting based on the assumption that Governor Dunleavy is aware of our request and reasons for meeting with him (see attached and below); and has instead chosen good people (Deputy Mills and Chief AAG Helzer) to act on his behalf. RE: Meeting with Governor Dunleavy and AG Taylor, for citizens to request an independent "Mollen" type commission be appointed to publicly investigate judicial corruption.

Ms. Mason,

Thank you for responding to our request.

I, and others, believe Deputy Attorney General John Skidmore is implicated in the same judicial corruption and cover-up we are trying to solve:

1. In 2018, a grand juror claimed that Mr. Skidmore unconstitutionally and illegally stopped the grand jury from investigating evidence of judicial corruption and cover-up. This included, but was not limited to: evidence that District Attorneys are falsifying evidence to frame citizens; evidence that the Alaska Commission on Judicial Conduct is falsifying official investigations to keep corrupt judges on the bench; evidence that the Office of Children's Services is violating law to take children from parents; and evidence that everything is being covered up by government officials.

2. Senator Peter Micciche (now Kenai Peninsula Borough Mayor) and Speaker of the House Mike Chenault investigated the grand juror's claims, driving from Kenai to Anchorage to question Mr. Skidmore in the presence of the grand juror. Mr. Skidmore claimed he could stop the grand jury investigation because *"no one claimed there was systemic corruption."* The grand juror protested, claiming that Mr. Skidmore had been positively told it was *"systemic corruption."* Senator Micciche and Speaker Chenault appeared to accept Mr. Skidmore's explanation. Long after, however, the grand juror succeeded in obtaining the court recording of when Mr. Skidmore successfully stopped the grand jury from investigating. The recording captures Mr. Skidmore outright being told *"by definition, this is systemic corruption."* 

To many of us it appears that Mr. Skidmore unconstitutionally but successfully stopped the grand jury from investigating judicial corruption, and then testified falsely to legislators to cover up what he had done. Article 1, Section 8 of Alaska's Constitution: *"The power of Grand Juries to investigate and make recommendations concerning the public welfare or safety shall never be suspended."* (no mention that investigations must concern *"systemic corruption."*)

3. In 2022 a grand jury foreman claimed that Mr. Skidmore stopped his grand jury from investigating the same judicial corruption. When he brought up the grand jury's constitutional right to investigate, the foreman claimed he was told the Alaska Constitution, *"didn't matter."* 

4. In 2023, in response to a proposed Kenai Peninsula Borough Assembly Resolution seeking to bolster citizen rights to appeal to the grand jury, Mr. Skidmore and Alaska Court System General Counsel Nancy Meade testified to the KPBA that citizens do not have a right to appeal to the grand jury. Yet page 1328 of Alaska's Constitutional Convention records the 55 delegates stating: *"The grand jury can be appealed to directly, which is an invaluable right to the citizen."* The 55 delegates who wrote Alaska's constitution also said: *"The power of grand juries to inquire into the willful misconduct in office of public officers, and to find indictments in connection therewith, shall never be suspended."* Alaska Constitutional Convention, December 15, 1955. *"The grand jury is preserved, for all purposes, particularly for investigation of public officials."* Alaska Constitutional Convention Commentary on the Preamble and the Declaration of Rights.

### **Conclusion**

Ms. Mason, in light of the above, compounded by the corruption and cover-up documented in our original request for a meeting with the Governor and Attorney General (attached), what do you think we should do?

We don't want to seem ungrateful for the opportunity to speak with Deputy Attorney General Skidmore. But since he already falsified testimony to legislators to apparently cover up that he is part of the problem, we believe he will do whatever it takes to prevent an independent "Mollen" type commission from publicly investigating the very corruption and cover-up he is implicated in. He now has a history of sabotaging meetings he is party to, and we believe he will sabotage the below proposed meeting.

The very reason we asked for a meeting specifically with Governor Dunleavy and Attorney General Taylor is because Deputy Attorney General John Skidmore, a very powerful government official, is directly implicated.

Unless you have a better idea, can you positively inform Governor Dunleavy and Attorney General Taylor of our concerns and that we would prefer a meeting with them, and then let us know what the Governor and AG think? One of our fears is that our requests get side-lined by someone like Mr. Skidmore, and the Governor and/or Attorney General never know what our concerns and requests are. In fact, did the Governor and Attorney General personally see our request and reasons for a meeting and was it they that suggested we meet with Mr. Skidmore? A growing number of folks think we may have to visit Juneau to make sure the proper people are receiving our concerns, but maybe this isn't the proper way to proceed?

**New York City's 1994 Mollen Commission (Appointed by Mayor Dinkins to Investigate in Public)** To cover up their corruption, officers created even more: they falsified official reports and perjured themselves to conceal their misdeeds. In the face of this problem, the Department allowed its systems for fighting corruption virtually to collapse. It had become more concerned about the bad publicity that corruption disclosures generate than the devastating consequences of corruption itself. As a result, its corruption controls minimized, ignored and at times concealed corruption rather than rooting it out. Such an institutional reluctance to uncover corruption is not surprising. No institution wants its reputation tainted – especially a Department that needs the public's confidence and partnership to be effective. Since no entity outside the Department was responsible for reviewing the Department's success in policing itself, years of self-protection continued unabated until this Commission commenced its independent inquiries.
