ALASKA REPUBLICAN PARTY RESOLUTION

RECOMMENDING THE ALASKA SUPREME COURT REPEAL SCO 1993 AND CRIMINAL RULE 6.1 AND IMMEDIATELY RELEASE THE KENAI PENINSULA GRAND JURY'S INVESTIGATIVE REPORT ON MARLA GREENSTEIN AND JUDGE MARGARET MURPHY

WHEREAS Article I, Section 8 of the Constitution of the State of Alaska states in part: "The power of grand juries to investigate and make recommendations concerning the public welfare or safety shall never be suspended;" and

WHEREAS In 1989 the Alaska Supreme Court passed, by a 3-justice majority, Rule 6.1, which allows officials to stop grand juries from investigating matters in violation of the constitution; and

WHEREAS at the request of an individual the Kenai grand jury investigated alleged misconduct by Marla Greenstein, the state's judicial investigator, regarding Judge Margaret Murphy; and

WHEREAS the Alaska Supreme Court then issued Supreme Court Order (SCO) 1993 eliminating the ability of individuals to appeal directly to the grand jury; and

WHEREAS the Kenai grand jury prepared a report of its investigation and recommendations on the matter; and

WHEREAS Judge Thomas Matthews sealed the report and dismissed the Grand Jury indictment of Judge Murphy; and

WHEREAS These actions have caused incalculable harm to Alaska citizens, is unacceptable, and will get worse if not addressed.

NOW, THEREFORE, BE IT RESOLVED BY THE ALASKA REPUBLICAN PARTY:

- 1. THAT SUPREME COURT ORDER 1993 AND CRIMINAL RULE 6.1 VIOLATE ARTICLE I, SECTION 8 OF THE CONSTITUTION OF THE STATE OF ALASKA AND MUST BE REPEALED.**
- 2. BE IT FURTHER RESOLVED THAT THE KENAI GRAND JURY REPORT OF ITS INVESTIGATION OF MARLA GREENSTEIN AND JUDGE MARGARET MURPHY ARE PUBLIC DOCUMENTS THAT MUST BE RELEASED IMMEDIATELY.**
